EXECUTIVE ORDER NO. 01 - 2024

RE-ORGANIZING THE TASK FORCE KALIKASAN PARA SA MAGILAS NA KAPALIGIRAN IN THE MUNICIPALITY OF SARIAYA, PROVINCE OF QUEZON.

WHEREAS, the Philippine Constitution mandates that the State shall promote the general welfare of the People;

WHEREAS, the Local Government Code of 1991 Section 16 states that the local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, problems related to land, air, and water pollution continuously beset the Municipality of Sariaya, Quezon endangering the people and ecological health and wellness;

WHEREAS, to exercise and to fully act in protecting the Sariaya's Environment, there is a need to create a TASK FORCE that will spearhead and intensify the campaign in all aspects of protecting the environment in a more wholistic and inclusive approach;

NOW THEREFORE, I, MARCELO P. GAYETA, by virtue of the powers vested in me by law as Municipal Mayor, do hereby ORDER:

Section 1. REORGANIZATION OF TASK FORCE KALIKASAN PARA SA MAGILAS NA KAPALIGARAN - It is hereby reorganized the Task Force Kalikasan Para sa Magilas na Kapitaligaran, hereinafter referred to as Task Force Kalikasan, in the Municipality of Sariaya, Province of Quezon.

Section 2. Duties and Functions. The Task Force Kalikasan shall perform the following duties and Functions:

- a. Act as a support arm of the Municipal Mayor to oversee the overall welfare of the Environment and Natural Resources of the Municipality;
- b. Perform, coordinate with and/or assist the concerned departments, offices, agencies, and Non-Government Organizations in the conduct of the following activities, among others:
- c. Inspection/Visitation of all Industries or Business Establishments,
- d. General Environmental Clean-up drives,
- e. Preservation of Municipal Forests, watersheds, tree parks, mangroves, greenbelts, and similar forest projects and commercial forest, like industrial tree farms and agro-forestry projects,
- f. Coordination with government agencies and non-government organizations in the implementation of measures to prevent and control land, air, and water pollution, and,
- g. Assessment of general condition of Sariaya's environment and Natural Resources.
- h. Conduct information and communication (IEC) activities to promote care for the environment;
- i. Assist/Lead in the development and implementation of technical or scientific researches in the protection, preservation and promotion of environment and natural resources;
- j. Ensure that environmental and social safeguards are strictly observed and adopted accordingly; and
- k. Conduct of regular monitoring, documentation, and reporting of all activities and operations related to the protection and preservation of environment and natural resources.
- l. Call the attention and process the filing of appropriate charges against persons or business establishments who violate the provisions of existing laws, policies, and/or ordinances on environment and/or related matters; and,
- m. Recommend policies and other measures to strengthen the efforts and drives to protect and preserve the environment and natural resources, including all its inhabitants;
- n. Perform other duties and functions as may be assigned by the Municipal Mayor.

Section 3. Meetings. The regularity of the meetings shall be determined in the internal rules that shall be developed by the body. In the interim, the Task Force shall convene or meet at least once every quarter; or as need arises.

Section 4. Repealing Clause. All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

Section 5. Funding. Funds needed to operationalize the Task Force Kalikasan shall be made available in accordance to the usual budgetary and accounting procedures.
